**APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE**

**THE UNDERSIGNED (HEREINAFTER CALLED THE "APPLICANT")**, hereby applies for membership in, and agrees to purchase electric energy from, French Broad Electric Membership Corporation, (hereinafter called the "Cooperative"), upon the following terms and conditions:

1. When the Cooperative makes electric energy available to the Applicant, the Applicant agrees to purchase from the Cooperative, and pay monthly to the Cooperative for all electric energy used on the premises owned or occupied by the Applicant in accordance with the rate schedule and rules and regulations established by the Cooperative and agreed upon by the Rural Utility Service of the United States of America. The Applicant further agrees to pay the minimum monthly bill in addition to the cost of all kilowatt hours consumed.
2. The Applicant will comply with and be bound by the provisions of the bylaws of the Cooperative, and such rules and regulation as may from time to time be adopted by the Cooperative.

The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force until canceled by either party. The Cooperative has the right to refuse service to a resident or business if it is determined that the person seeking service is attempting to evade payment of a past-due account or assisting someone else evading a past-due account.
